I WILL ABIDE BY THE COVID SAFE EVENT PLAN REQUIREMENTS SET OUT BELOW FOR THE MARKETS HELD IN CONJUNCTION WITH THE EMU PARK LIONS & TRIPLE M (CQ) FESTIVAL OF THE WIND -

All stallholders:

- Please do not attend the Festival if:
 - You have been in close contact with a person who is positive for COVID-19;
 - You are an active COVID-19 case;
 - In the last 14 days you have travelled overseas or to a declared COVID-19 Hotspot;
 - You are unwell, eg experiencing coughs, fever, sore throat, fatigue or shortness of breath.
- Direct workers to stay home if they are unwell, and to go home immediately if they become unwell;
- If you need to pay cash (market stall fee), the exact amount must be presented upon entry to the grounds.

- No seller is to enter the market area before payment is made. No exceptions.
- It is a requirement that all stalls have sanitizer available for use by patrons and staff.
- All stallholders must maintain physical distancing at their stalls and monitor queuing ie 1 person/1.5m².
- Stalls with walk in patrons must display in their stall "maximum number of persons permitted" signage under COVID density requirements eg 1 person/2m²
- If possible, limit the number of cash transactions by encouraging customers to use tap and go, direct deposit or other contact-less payment options. Cash must be sanitized immediately it is received before placing in your cash box.
- Have a regular & thorough cleaning schedule in place before, during and after the event ensuring surfaces
 are disinfected, paying extra attention to high contact areas such as door handles, counters, railings, taps
 and food preparation areas. Ensure adequate cleaning supplies are on hand & that hand washing & alcoholbased hand sanitizers are re-stocked frequently.

Food stalls (in addition to the above):

- One-way queuing away from other foot traffic areas to have mesh barriers with 1.5m ground marks for physical distancing & allowance for collection space (event organizers to assist with this requirement);
- Food stallholders, including staff, need to provide an assurance that their food/beverage training has been completed. Training can be done on-line with TAFE Qld's COVID-19 response free micro-credentials and skill sets https://tafeqld.edu.au/covid-safe [scroll down to "Covid Safe for Dining In" register, create account and complete the course a Certificate is issued on completion of the course.]
